REQUIRED DOCUMENTS	<ol style="list-style-type: none"> 1. Application Form 2. Passport; 3. Official nomination letter from sending institution; 4. Academic Transcript; 5. Learning agreement; 6. Proof of Language Proficiency, if available.
COURSES	<p>The courses or academic programs should be approved BEFORE the mobility with the academic mobility coordinator of the relevant faculty. FEES AND OTHER EXPENSES

TUITION FEES	Students participating in the inter-institutional exchange are required to pay tuition fees to their home institution, the tuition is waived at KazNU.
ACCOMMODATION	On campus accommodation prices (*as of 2023 subject to change): -

ACCOMMODATION TYPES	<p>On campus accommodation is limited, and firstly allocated among the full program students. The university will provide accommodation for international exchange students upon availability.</p> <p>Students can rent private accommodation off campus, in such case they are responsible for making their own arrangements.</p>
HEALTH INSURANCE	<p>The international students must take care of their personal insurance beforehand.</p> <p>All students can register with the Smart Health Medical Centre on campus.</p>

VISA APPLICATION

VISA APPLICATION	<p>After receiving the application form and other documents they are forwarded to the visa support and registration Center of KazNU.</p> <p>The visa support and registration center proceeds with visa application to the Migration police of Almaty city. When the application is approved, the Visa support and registration center sends back the approved documents to the student. The application approval takes from 2 weeks to 1 month.</p> <p><i>The students should reimburse the visa application fee to the Centre or the Faculty in the amount of 1846 KZT+250 KZT bank fee (for 2024)</i></p> <p>Student Visa – 113 000 KZT (for 2024)- paid at the Embassy/Consulate.</p> <p>Prices are relevant for 2024.</p> <p>NB! Some Embassies/Consulates might record biometric data (fingerprints)</p>

ARRIVAL & ORIENTATION

AIRPORT COLLECTION	<p>International Students are responsible for their arrival, there is no transfer available now due to covid restrictions.</p> <p>In order to avoid problems with dormitory registration, we kindly ask the students to arrive on workdays.</p>
DOCUMENTS REQUIRED ON ARRIVAL	<p>Upon arrival WITHIN 2 WORKING DAYS all international students should provide their passports to the Visa support and registration center for “Foreign Citizen Arrival Notification”.</p> <p>The students DO NOT HAVE to go to the Migration office on their own, the Visa support and registration center will make the notification for students.</p>
